#### **Old Business:**

- Conference Wrap Up
  - Adrian Alan, Brian Casey, and Holly Hakes to be paid once checks come in
  - Kevin to pay for the resort after meeting
  - Pizza Pub bill was \$225. Kevin to pay after meeting
  - Nick and Tyler talked about potentially making 2 sets of WFTOA bean bag boards to leave in the storage unit. Believe it would cost around \$200 for the boards and about \$80 for the bags. To put together a quote package for the next meeting
  - Day 2 of the conference was a little slower paced with drier material

  - AV not working properly
  - Less vendors than last year. No Uniform Shop

- Conference Invoice
  - Total of \$11,428.30

- Resort charged us for Dawn's room (\$270) however her room was not comped by the organization
- Charged Chaplain Ray for 3 nights when he only stayed 1 (\$270 instead of \$90)
- FTO of the Year's room was \$129/night instead of \$90/night
- After correcting the above issues, the bill came to \$10, 861.30
  - Rooms = \$4,050.00
  - AV / Meals = \$6,811.30
